The Quotation should be in sealed cover superscribed "Quotation for Purchase of Old Vehicles" & may be sent by Registered Post or Hand Delivery so as to reach at ICAR-Central Institute for Research on Cotton Technology, Near Five Gardens, Adenwala Road, Matunga (East), Mumbai- 400 019 on or before 15-02-2020 at 11:30 A.M. The quotations received after due date & time will not be accepted. The vehicles will be available for inspection between 2:00 P.M. to 4:00 P.M. at ICAR-CIRCOT, Mumbai Premises on all working day till 14-02-2020.

3. The tender will be governed by the following conditions:-

- i) The bidder is required to pay earnest money Rs 2000/- (Two Thousand only) for Condemned vehicle to be paid by means of Demand Draft drawn in favour of "The Director, CIRCOT, Mumbai" payable at Mumbai.
- ii) The bidder has to quote for both the two vehicles with the requisite EMD.
- iii) Quotation received without Demand Draft towards EMD will not be accepted.
- iv) The successful bidder will be required to deposit the bid amount including GST by means of Demand Draft drawn in favour of "The Director, CIRCOT" payable at Mumbai within two days of the acceptance of bid.
- v) EMD will be forfeited if the successful bidder fails to honor the bid. The EMD of the successful bidder will be released only after transfer of registration of vehicles in her/his name. The EMD of successful bidder will be return after finalization of tender.
- vi) The delivery of sold vehicle will be arranged only after the successful bidder submit documentary evidence in support of residential status viz. Aadhaar Card/Voter Identity Card/Passport in case of Individual and Registration Certificate in case of firm etc.
- vii) The sold vehicles will be removed by the successful bidder from the premises of ICAR-CIRCOT Mumbai within five working days at their own expenses after issue of sale letter by ICAR-CIRCOT, Mumbai.
